

## **Contest Rules**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

### **1. Eligibility**

Giving the Gift of Heat to a Veteran (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Contest winners must reside in Ocean County, NJ. Employees of Comfort Zone Home Services and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

### **2. Sponsor**

### **3. Agreement to Official Rules**

## **5. How to Enter**

**On-Site:** This method of entry will be available at Comfort Zone Home Services Office, 527A Mill Creek Road, Manahawkin, New Jersey 08050.

**Online:** This method of entry will be available by visiting our website (<https://www.czhvacr.com/>) and following the directions provided to fill out the entry information, and submit.

**Via Text Message:** This method of entry will be available for the entire Contest Period. Send a text message with Furnace Giveaway for a Veteran from your handset to the short code 609-342-3144. In response to this text message, an auto-reply will be sent to the device. Follow the directions provided in the reply to confirm your entry. Standard text and data rates will be charged for each text message sent or received from your handset according to the terms of your carrier. Check with your wireless carrier for your handset capabilities and pricing plan details.

**Via Mail:** This method of entry will be available for the entire Contest Period. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date of birth and email address (optional) and mail in an envelope with proper postage affixed to: Po Box 760, Manahawkin, New Jersey, 08050 Mail-in entries must be hand-printed and mailed in separately. All mail-in entries must be postmarked by December 15, 2024 and received by December 15, 2024.

Limit one (1) entry per person, per email address, per mobile phone number, and per household for the duration of the Contest Period, regardless of method of entry. Winner must reside in Ocean County NJ. Entries received from any person, e-mail address, mobile phone number, or household in excess of the stated limitation will be void. All entries become the property of

Sponsor and will not be acknowledged or returned.

## **6. Prize Drawing**

On or about December 20, 2024, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about December 20, 2024. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

## **7. Winner Notification**

The potential winners will be notified by announcement on social media, email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winners behalf and fulfill any other requirements imposed on winner set forth herein. ## **9. General Conditions**

The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

## **10. Release and Limitations of Liability**

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) lost, late, incomplete, garbled, illegible, undelivered, stolen, damaged, delayed, postage-due or
